The Jacob Fretz collection was given to the Mennonite Archives of Eastern Pennsylvania during 1979 over a period of several months. Jacob has been a life long resident of Bucks County, Pennsylvania and a member of the Blooming Glen Mennonite Church. As a young man he began to collect historical books and papers that dealt with Mennonite history. Jacob has been quite eclectic in his accumulation of historical material and has not restricted himself to only Mennonite information. Prior to his donation to the MHEP Jacob had several public sales of some of his material.

Along with manuscript material that was donated to the MHEP Jacob gave several thousand books. Most of these books were either in very poor condition or were totally unrelated to Mennonite and Bucks County history. The Historical Library and Archives found it necessary to dispose of many of the books from the Fretz collection. The manuscript collection has been kept in its original order and condition.

The Jacob Fretz manuscript collection is strongest in the area of Buck County Mennonite history. The researcher will find the many Public Vendues from the Mennonite community of Bucks County to be quite useful. Note should also be made of folders 19, 22, 83, 84, and 115.

The photocopies that are a part of the collection were copied from originals that are in the care of Jacob's brother, Clyde Fretz, of the Blooming Glen congregation.

There are no restrictions on the use of this collection other than the standard guidlines of the Mennonite Historical Library and Archives of Eastern Pennsylvania.
